- Link Deletion: When a user deletes a link, we record the deletion date for service maintenance, security, and data accuracy purposes.
- Security: We use the data to monitor for any potential issues or security threats related to the uptime monitoring service.

#### 3. Data Retention

• We retain user-submitted data, such as uptime links and server IDs, for as long as necessary to provide the uptime monitoring service.

- If a link is deleted, the deletion date is recorded, but the link itself is removed from our systems.
- Upon user request, we will delete all associated data, including user IDs, links, and server IDs.

## 4. Your Rights

You have the following rights concerning your data:

- Access to Data: You may request access to any data we have collected about you.
- Deletion of Data: You can request that we delete your data, including links, server IDs, and user IDs, at any time.
- Correction of Data: If any information is incorrect or incomplete, you may request that we correct it.

We take reasonable precautions to protect your data from unauthorized access, alteration, or destruction. While we implement robust security measures, please be aware that no method of transmission over the internet is 100% secure, and we cannot guarantee absolute security.
